## PRODUCT CENTRAL 127 NEUTRA-QUAT 32

Strictly for use against Candida auris and Canine Parvovius, Product Central 127 Neutra-Quat 32 is a one-step disinfectant, cleaner, virucide\* for use in hospitals, institutional, and industrial facilities. Easily cleans and disinfects, when used according to directions. Use this product on washable hard, non-porous, non-food contact surfaces of: floors, walls, countertops and bathroom fixtures. Neutra-Quat 32 is effective against the fungi, Candida auris, and the animal virus, Canine Parvovirus, at a dilution of 4 ounces of concentrate diluted with 1 gallon of water, with a 10 minute contact time.

## **DIRECTIONS FOR USE:** Dilute with cold water.

Rinse all surfaces that come in contact with food such as countertops, appliances, tables and stovetops with potable water before reuse. Do not use on utensils, glassware and dishes

**Preparation of Disinfectant Use-Solution** To kill Candida auris, dilute 4 oz. of the concentrate with water to make 1 gallon of the disinfectant solution (1:31). To kill Canine Parvovirus, dilute 4 oz. of the concentrate with water to make 1 gallon of disinfectant solution (1:31).

**Disinfection** / **Virucidal** / **Fungicidal:** Apply use-solution to hard, non-porous, non-food contact surfaces, thoroughly wetting surfaces with a cloth, mop, sponge, sprayer or by immersion. Treated surfaces must remain visibly wet for 10 minutes. Wipe dry with a cloth, sponge or mop or allow to air dry. For visibly soiled areas, a preliminary cleaning is required.

**Special Instructions for Cleaning Prior to Disinfection against Candida auris** 

**Personal Protection:** Wear appropriate barrier protection such as gloves, gowns, masks, or eye covering.

Cleaning Procedure: Fecal matter/waste must be thoroughly cleaned from surfaces/objects before disinfection by application with a clean cloth, mop, and/or sponge saturated with the product. Pre-cleaning is to include vigorous wiping and/or scrubbing and all visible soil is removed. Surfaces in patient rooms are to be cleaned in an appropriate manner, such as from right to left or left to right, on horizontal surfaces, and top to bottom, on vertical surfaces, to minimize spreading the organism. Restrooms are to be cleaned last. Do not reuse soiled cloths.

**Infectious Waste Disposal:** Materials used in the cleaning process that may contain feces/wastes are to be disposed of immediately in accordance with local regulations for infectious materials disposal.before application of this product.

**Contact Time:** Leave surface visibly wet for 10 minutes with 4 oz. per gallon use-solution.

**Disposal of Infectious Material:** Blood, body fluids, cleaning materials and clothing must be autoclaved and disposed of according to local regulations for infectious waste disposal.
